Principles

intec GOPA-International Energy Consultants GmbH's Code of Conduct is derived from the company's mission and common corporate values. - carefully selecting members of its head office management and personnel, external experts and cooperation partners;
- assuring compliance to the Code at intec GOPA-International Energy Consultants GmbH's headquarters and in project offices worldwide; and
- applying the Code when dealing with cooperation partners, donors and all stakeholders in projects that intec GOPA-International Energy Consultants GmbH implements.

Application

The Code of Conduct applies to all **intec** GOPA-International Energy Consultants GmbH's staff, i.e. management and other employees at the **intec** GOPA-International Energy Consultants GmbH head office and team leaders, team members, short- and long-term experts in the field as well as company representatives, and is part of **intec** GOPA-International Energy Consultants GmbH's employment contracts and contracts with representatives, partners and experts.

Standards

Transparency

Partnership

Partnership is characterised by mutual respect, trust and confidentiality. **intec** GOPA-International Energy Consultants GmbH strives for a partnership-based cooperation with associate firms, and freelance experts deployed in its projects. The same applies to its cooperation with donors, beneficiaries, target groups and authorities in the projects implemented.

Conflict of interest

By having the respective contractual arrangements and obligations in place **intec** GOPA-International Energy Consultants GmbH takes care to separate business and private spheres and to immediately reveal conflicts between personal interests and **intec** GOPA-International Energy Consultants GmbH's corporate interests in order to resolve them in a verifiable and understandable manner for all parties involved. Any paid or honorary activity of personnel related to **intec** GOPA-International Energy Consultants GmbH's field of activities and falling outside employment contracts with **intec** GOPA-International Energy Consultants GmbH has to be reported to and possibly approved by the management. The same applies to any connections of personal, familial, financial or of any other nature a staff member might have to **intec** GOPA-International Energy Consultants GmbH's clients, business partners, competitors or their employees, which could impinge on the objectivity of the staff member's work.

Bribery

intec GOPA-International Energy Consultants GmbH disassociates itself from active and passive bribery and neither encourages nor tolerates the direct or indirect acceptance of bribes or the offering of bribes.

Gifts

intec GOPA-International Energy Consultants GmbH personnel is not allowed to accept gifts from or to make gifts to business partners, except for small give-aways such as pens, stickers, etc., which do not exceed a commercial value defined by the applicable law/regulation per employee or business partner per year. **intec** GOPA-International Energy Consultants GmbH staff may accept occasional lunch or dinner invitations or may invite business partners to lunch/dinner, as these are informal work platforms between **intec** GOPA-International Energy Consultants GmbH and its partners.

Violations

If **intec** GOPA-International Energy Consultants GmbH's management becomes aware of the fact that a partner or an employee has violated the Code of Conduct, whether explicitly or by implication, it will act in each individual case by carefully evaluating the degree and the seriousness of the contempt and undertake the necessary action.

Where a staff member, a business or project partner or any other person considers that the principles of this Code are not being upheld, he/she shall address the compliance officer designated for the purpose of reviewing compliance with this Code of Conduct (compliance@gopa-group.org) who acts independently and autonomously. Any information provided will be handled with strict confidentiality.
